

ELSA IE offers several scholarship options to help members with the cost of membership fees. These scholarships are designed to provide financial assistance to members who may be facing financial hardship or who have demonstrated exceptional academic achievement.

The President's Scholarship is a full scholarship that waives all membership fees for the recipient. To apply for this scholarship, members must submit an application demonstrating their financial need or other qualifications.

The Secretary's Scholarship is also a full scholarship that waives all membership fees for the recipient. Like the President's Scholarship, it requires an application demonstrating financial need or other qualifications.

The Executive's List Scholarship is a partial scholarship that waives the semesterly membership fee for the recipient. To be eligible for this scholarship, members must have a GPA of 9.5 or higher.

The General Financial Aid scholarship is available on a case-by-case basis to members who may need financial assistance, or any member who is or has been impacted directly by the war in Ukraine. To apply for this aid, members should contact treasurer.ieuniversity@es.elsa.org.

ELSA IE's scholarship options are designed to provide financial assistance to members who may be facing financial hardship or who have demonstrated exceptional academic achievement. These scholarships help to ensure that enrollment in ELSA is accessible to all members, regardless of their financial circumstances.
